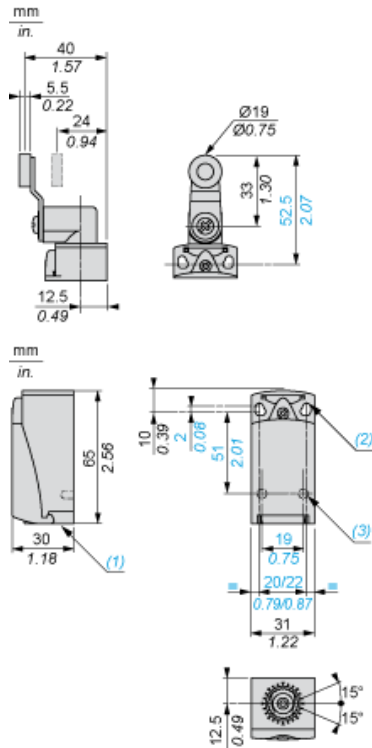

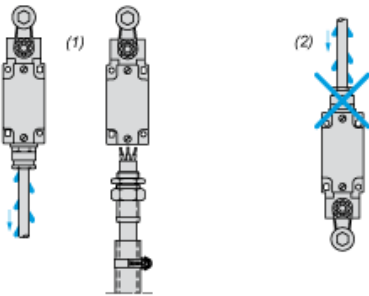

Mounting with Cable Entry

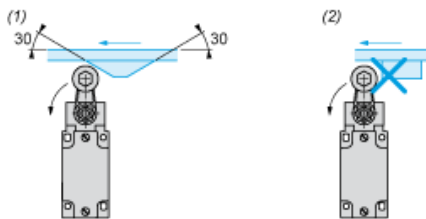
Position of Cable Gland

- (2) To be avoided

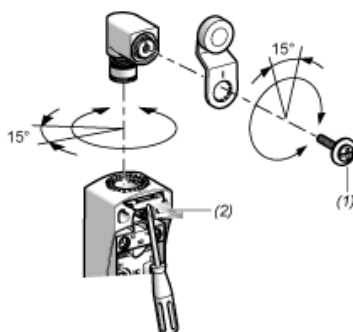
Mounting with Rotary Heads and Levers

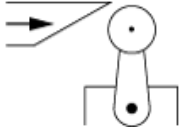
Wiring Diagram

2-pole NC + NO Snap Action

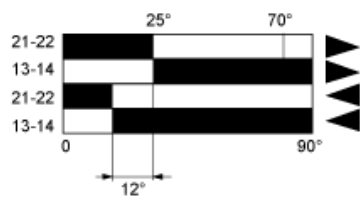


Characteristics of Actuation
